### **Wedding Contract**

This agreement is between RJ Bradbury Photography and .....Date of wedding.....

- 1.** This agreement contains the entire understanding between RJ Bradbury Photography me and the Client. It supersedes all prior and simultaneous agreements between the parties. Only those changes or modifications specifically placed in writing, attached, dated and signed by the Clients and RJ Bradbury Photography at the time of acceptance of this contract shall be recognised as amendments to this contract.
- 2.** Upon receipt of deposit, RJ Bradbury Photography will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Reservation deposit of 25% of the coverage is non-refundable, even if the date is changed or the wedding cancelled for any reason; including acts of God, fire, strike and/or extreme weather. The Reservation Deposit is to be paid at time of signing the contract. The Reservation Deposit is applied towards the contracted wedding photography package.
- 3.** In the event that the Client cancels the contracted services for wedding photography outlined in this contract before the wedding ceremony takes place, the deposit will be forfeit. RJ Bradbury Photography agrees to refund all additional paid money (less expenditures for which receipts will be provided), to the client
- 4.** The Client understands and agrees that the entire amount owed for the wedding photography package is due four weeks before the date of the wedding.
- 5.** The Client is responsible for the photographer's transport costs to and from the wedding venue.
- 6.** The Client is responsible for the costs of any accommodation required by the photographer.
- 7.** The client is responsible for providing a hot meal for the photographer, served at the same time as the wedding dinner. Or Advising the photographer that a meal will not be provided at the point the booking is confirmed.
- 8.** In the unlikely event of severe medical, natural, or other emergencies, it may be necessary to retain an alternative photographer. RJ Bradbury Photography will make every effort to secure a replacement photographer of the same professional standing and ability able and/or willing to provide a similar package as chosen in this contract at the same/similar tariff. If such a situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received.
- 9.** RJ Bradbury Photography takes the utmost care with respect to exposure, transportation and processing of photographs. However, in the unlikely event of the Client's photographs being lost, stolen or destroyed for reasons within or beyond RJ Bradbury Photography's control, the latter's liability is limited to the return of all payments received for the event package, together with the reasonable costs of restaging photographs of the couple and their families at a later date.
- 10.** The Photographer will document the events in a candid manner and take formal portraits as necessary. The client should provide a full list on the details form of formal photographs required including names and relationship to the client.
- 11.** Prior to or during the event, the Client may inform the photographer of subjects which they would like photographed, but the final content of the images is at the discretion of the Photographer.

**12.** Although every possible care will be taken to produce photographs of all important and special events during the wedding, RJ Bradbury Photography cannot place an unconditional guarantee on the above.

**13.** The client will receive an edited selection of high-resolution JPEG digital images. The entire copyright in the photographs is retained by the photographer at all times throughout the world. The client must seek permission for use beyond reproduction and printing for friends, guests and family.

**14.** The Clients hereby allow the photographer to display any images covered by this contract and to generally promote the business by means of advertising, publicity material, websites, exhibitions, competitions, magazine articles, and other such media, providing that the images are used lawfully and without damage to the clients.

**15.** The Client understands that delivery will be 4-6 weeks but RJ Bradbury Photography will endeavor to deliver sooner where possible.

**16.** The client understands that no unedited images will be released, and RAW files will NOT be provided.

**17.** The photographer is limited by the guidelines of the ceremony official or the reception site management. The Client agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is The Client's responsibility; RJ Bradbury Photography will offer technical recommendations only.

**18.** RJ Bradbury Photography and associates will be the only professional photographer(s) on the day of the wedding. RJ Bradbury Photography reserves the right to ask other people to refrain from taking photographs at key times, if it is considered that this may compromise the quality of the photographs.

**19.** RJ Bradbury Photography & Associates will not tolerate any level of verbal abuse or aggression. Either will result in the immediate suspension of coverage.

**20.** RJ Bradbury Photography & Associates will not be responsible for arranging (fire works, sparkler, fire, water) shots but will photograph the coverage. Will not be held responsible for any damage, injury to any property or person during such events.

**21.** If any provision of this agreement is held to be invalid or unenforceable under the law, the validity of this agreement as a whole shall not be affected, and the other provisions of the agreement shall remain in full force and effect.
